# BYLAWS MADE PURSUANT TO THE ARTICLE 11.7 OF ENDIP CONSTITUTION AND ADOPTED BY THE BOARD ON FRIDAY 04/10/2019

### A. Membership

- Pursuant to Article 6.1, each ordinary member will pay non- refundable fee of Kshs.1,000 sent to treasurer via Mpesa inclusive of withdrawal/ transfer charges or deposited directly to NGO Bank Account
- 2. Pursuant to Article 6.12 and 6.13, the list of registered members and details therein shall be kept by the Secretary.

#### B. Board of Directors

- 3. Notice of Board Meeting
  - a) Pursuant to Article 14.2 and 14.3, a notice of a board meeting shall be issued via Board of Directors WhatsApp group or SMS/ Call to individual Board Members.

## 4. Means of convening a meeting.

- a) Pursuant to Article 14.4, the Board may conduct meeting in following ways
  - i. physical meeting
  - ii. online meeting via WhatsApp
  - iii. both physical and direct calls/conference on the directors not present at the meeting
- 5. Quorum of the Board
  - a) Although the Article 14.7 of Constitution put the quorum of the Board at 2, all Board members would endeavor to attend physically or by any other online means provided.
- 6. Chairing of meetings
  - a) Pursuant to Article 11.1, 12.28 and 14.10 in absence of Chair, the Secretary shall chair the meeting and in absence of Secretary the Treasurer.
  - b) In absence of chair, secretary and treasurer, the board of directors shall elect one of them to chair the meeting.
- 7. Filling a vacancy in the Board
  - a) Pursuant to Article 11.4 and 14.5, if the Board Membership falls below the required 9, the Board may in a resolution invite any member to express interest in serving in the Board

- b) After candidate express interest, then election would be conducted by a board member
- c) Election would be done via online voting by members if physical meeting is impossible
- d) The board member would then announce the results
- e) Each election of a board membership must reflect the gender balance
- f) The filling of vacancy of chair, secretary or treasury would be done only from existing directors by majority votes among them

- 9. Amendment/alteration or addition
  - a) The board may in a majority vote amend, alter or add any by law to cater for the unique circumstances of the NGO
  - b) Such amendment, alteration or addition shall not be inconsistent with NGO constitution
